The question of the internationalization and transferability of Vocational Education and Training (VET)system approaches and the possibility of VET export play a major role in international VET cooperation. Particularly in German-speaking countries with a very distinctive and well-established VET system, this topic is continuously discussed. At the same time, the latest research findings regarding feasibility, successes already achieved, challenges to be overcome and long-term feasibility of VET international transfer are very limited. This special issue addresses this shortcoming and aims to bring together findings from different research projects addressing the topic of the internationalization and transferability of VET systems. To this end, the findings from eight contributions are presented and discussed.

#### Successful completion of the CodeVET project

The project 'Competence development in VET. A comparative analysis of intended and implemented curricula in the field of business administration (CodeVET)' was successfully completed at the end of October 2022. The project has been able to collect interesting data on competence-oriented teaching in commercial vocational schools in China and Russia under difficult conditions in recent years.

## Successful completion of the DualReg project

The project 'Locally rooted – worldwide linked up: Mexico – Success conditions for transfer of vocational education and training and dual practices (DualReg)' was successfully completed at the end of October 2022. The project has been able to conduct field research under difficult conditions in recent years in different regions of in North and South of Mexico.

## Starting of the Erasmus+ Project RecoVET

The project 'Recognition of Good VET practices for refugees (RecoVET)' develops a concept for the external evaluation and recognition of specific quality of refugee integration based on the results from the former project 'Good VET'. The concept of quality recognition is transferred into three products. Firstly, they consist of an online training course for quality auditors to prepare them for the specific challenges of refugee integration. As a second product, a supplementary handbook for quality recognition and accompanying literature for the online training will be developed. The third product is a practice-oriented toolbox for the implementation of evaluation and recognition (for more details: <a href="https://recovet.uni-koeln.de/en/">https://recovet.uni-koeln.de/en/</a>).
